The National Environment and Planning Agency (NEPA) and the Kingston and St. Andrew Municipal Corporation have been called on to exercise their authority and ensure that housing developers do not infringe on citizens' rights.

The matter was raised at Parliament's Infrastructure and Physical Development Committee on Thursday (January 19), when it deliberated on submissions made by the Citizens Rights Group – an amalgamation of almost 30 associations across Kingston and St. Andrew.

Committee member Julian Robinson noted that many developers have been breaching the Provisional Development Order established in 2017, which sets out the framework, guidelines and policies for planning and development in parishes and communities.

Opposition committee member Julian Robinson stressed that, unfortunately, these are widespread breaches, noting that "they are the norm, not the exception".

"There are court cases that private residents have brought and there have been judgments which have raised serious questions about, in particular, these two entities [KSAMC and NEPA] in relation to how building permits are handled. And there are citizens' groups that have raised a number of issues around it," he said.

Robinson said he was recommending that, in relation to this specific report, the two entities cited – the KSAMC and NEPA – be referred to the Infrastructure and Physical Development Committee, given the issues that were raised in this report.

The parliamentary opposition has called for the Bank of Jamaica to intervene in the growing crisis facing customers seeking to withdraw or deposit cash at automated teller machines (ATMs) across the island.

There are growing call for banks to provide more ATMs across Jamaica as customers are faced with undesirable circumstances the machines.

Customers have been complaining of long lines and lack of cash at the machines.

Speaking with *Radio Jamaica News* on Friday afternoon, Opposition Spokesman on Finance Julian Robinson dismissed claims by the Jamaica Bankers Association that increased vandalism and attacks on courier vehicles have contributed to the crisis.

According to Mr. Robinson, local banks are failing to fulfill their obligations to their customers as required by law.

"There's some basic minimum service standards that every single financial institution should abide by. If you have ATMs, they should be operational let's say, for example, 75% of the time, which means that if you're going there to do transaction, like with drawing cash, they should have cash."

The problem, he said, is that banks are "forcing people out of branches", telling them to use online means of banking, but are failing to do their part in ensuring their systems work.

KINGSTON, Jamaica - The Opposition People's National Party is calling on law enforcement officials to provide an update on the status of investigations into the massive fraud uncovered at Stocks and Securities Limited (SSL).

In a release on Wednesday, Opposition Spokesman on Finance, Julian Robinson, said, "It is critically important that the public be kept abreast of the progress being made by law enforcement officials in this important case. While it is in the public domain that one individual has been arrested and charged, we want to know whether other persons are being pursued and the status of those probes."

Robinson said it is important to note that the hundreds of investors who were fleeced of their monies, have no idea whether they will be repaid and have received no communication at all about the ongoing probe.

KINGSTON, Jamaica— The People's National Party (PNP) has expressed concern and shock at the reported theft of several laptops from the offices of Stocks and Securities Ltd (SSL), which is currently embroiled in a multibillion dollar fraud probe.

The PNP said in a release on Thursday that the recent development raises critical questions about the integrity of the ongoing investigation.

The Opposition added that it is "deeply troubled" by the apparent security breach at SSL which it believes poses a significant risk of compromising crucial information vital to the investigation.

"It is unacceptable that potential evidence, stored within these laptops, might be tampered with or destroyed, hindering the pursuit of justice," the PNP said.

Opposition Spokesman on Finance, Julian Robinson stated that Thursday's theft at SSL is "profoundly unsettling" as it was revealed on Wednesday that the fraud at the financial institution has occurred on a larger scale than initially reported.

Opposition Spokesman on Finance Julian Robinson has taken the Statistical Institute of Jamaica [STATIN] to task for what he calls its poor management of the 2022 population and housing census.

STATIN has released multiple deadlines for the completion of data collection on the census but the exercise has been delayed by a number of issues including the agency's inability to retain workers.

The agency's last deadline for the completion of data collection was March this year; however, since then it has not been able to provide a satisfactory update on the progress of the exercise.

Mr Robinson, speaking Monday on Radio Jamaica's *Beyond the Headlines*, reiterated his call for Finance Minister Dr. Nigel Clarke to intervene and find a solution to issues affecting the completion of the census.

At a press conference last week, Deputy Director General of STATIN Leesha Delatite-Budair said the agency was wrapping up the census but declined to give further details.

Update on road repairs


- In spite of the roads repaired last year, the heavy rains of October have placed some of these same roads in need of repairs.





